As you move forward in this role, you'll have access to resources on-demand on Ambassador Portal on the H4HC website, and you schedule a 1:1 anytime with a member of our Grassroots Advocacy Team at advocacy@heartsforhomecare.com.

In addition to these resources, here are some tips for getting started and building your skills as a H4HC Ambassador:



1. Training & Education:



 In addition to monthly training opportunities, every year, H4HC hosts an Annual Ambassador Training in Pennsauken, NJ and Charlotte, NC. If you are unable to make it in-person, or if the yearly training has passed, be sure you attend a Virtual Ambassador On-boarding Call to learn how to get started in your role.

2. Follow H4HC on Social Media:



 We are on X, Facebook, and Instagram. Follow us to see updates from advocates across the country and easy to share opportunities to get involved with others on your social media channels.

3. Sign-up for your elected officials' newsletters:



• Use <u>H4HC's Lawmaker Look-Up tool</u> to identify your state and federal lawmakers, then simply google their names and find their websites. Most of the time, lawmakers have a newsletter that constituent can subscribe to. This is a great way to keep up-to-date on opportunities to engage your lawmakers indistrict, and to get an idea of what issues matter most to them.





4. Connect 1:1 with Your Grassroots Advocacy Team & State Director:



Once you've received your on-boarding training and you're ready to get more involved, schedule some time to meet with the Grassroots Advocacy Team and, when applicable, with the GAO State Director in your area. We can loop you into state-specific opportunities to get involved based on what specific interests you have!

5. Make an Action Plan:




